RULES AND REGULATIONS

IN ORDER TO QUALIFY FOR CONSIDERATION FOR ANY SHOW, POTENTIAL ARTISANS MUST AGREE TO ADHERE TO THE FOLLOWING:

New artisans must submit photos of their work or items offered for sale, along with photos showing how their work will be presented and displayed at an Art Attack event. Email photos to artattackaz@gmail.com.

Your photos will be kept on file and only need to be resubmitted if you add new products or significantly change your presentation.

Communication and registration will be maintained under your name rather than your business name.

Please wait for approval to participate in Art Attack Art Shows before submitting your application and payment. Formal acceptance letters are not issued.

Participation is approved following review of both your work and your proposed presentation.

Payment for each show must be submitted with your application.

Art Attack events are curated artist showcases. Wholesale or retail resale merchandise, self-promotion unrelated to the approved work, garage-sale items, antique resale, storage-buyout merchandise, flea-market items, or other unapproved merchandise will not be accepted.

Spaces are not guaranteed without payment. Sign up early, as available space and artisan categories are limited. No discounts, rain dates, rollovers or refunds. No exceptions.

SPACE ASSIGNMENTS

Space assignments and mandatory artist parking instructions will be provided at setup. Your name will identify your assigned space. All artists sharing a space, as well as employees or guests assisting within an artist's display area, must park in designated Artist Parking. Exceptions may be made for medical reasons.

Spaces will not be assigned without full payment. Special requests will be considered but cannot be guaranteed. Staking or anchoring into the property is prohibited. Art Attack reserves the right to limit product categories in order to maintain a well-balanced, curated show.

ARTIST DISPLAYS & PRESENTATION

Artists are encouraged to create an attractive, professional presentation that complements their work and contributes to the overall Art Attack experience.

All artist spaces require an all-white canopy for the 2026–2027 season. Canopies must be secured with a minimum 40 lb. attached weight at each corner. Water jugs and cinder blocks are not permitted. No weights — no setup.”

Artists may also use professionally presented tables, freestanding displays, easels, racks, pedestals or other approved presentation formats appropriate to their work and assigned space.

Tables must be fully draped to the ground. Artists are responsible for providing all materials required for their individual presentation.

All displays should be tasteful, professional, safe and visually inviting, with the goal of showcasing the artist's work while contributing to the curated atmosphere of the event.

Art Attack Promotions reserves the right to determine whether all artwork, products and presentations are appropriate for its events. Wholesale or retail resale merchandise, self-promotion unrelated to the approved work, garage-sale items, antique resale, storage-buyout merchandise, flea-market items or other unapproved merchandise are not permitted.

SHOW HOURS & SETUP

Setup begins after 2:00 PM the day before the show and from 7:00–9:30 AM the day of the show. All artists must check in before setting up. Your name will identify your assigned space.

All displays must be completely set up and ready for business by 10:00 AM. No vehicles are permitted in the show area after 9:30 AM.

Show hours are:

Friday & Saturday: 10:00 AM–5:00 PM
Sunday: 10:00 AM–3:00 PM

All artists are expected to participate for the full show unless otherwise approved.

Nightly security will be provided; however, this does not relieve artists of responsibility for their displays, equipment, artwork or merchandise.

ARTIST RESPONSIBILITIES

Designated artist parking areas. Remove all trash from your space at the end of each day and take it with you. Do not dispose of artist trash in portable containers, store trash cans or other property receptacles unless specifically authorized.

Smoking, vaping and disposal of smoking-related materials are prohibited on show grounds.

Artists must conduct sales from within their assigned presentation area and may not follow customers into another artist's space to solicit a sale.

Discount signage, political signage and political products are not permitted.

No early breakdown is permitted.

Artists are responsible for obtaining and maintaining all licenses and permits applicable to their participation, including Arizona TPT licensing and applicable health department permits for food vendors.

LIABILITY WAIVER / HOLD HARMLESS

I release and hold harmless Art Attack Promotions, the property owner, property management company, tenants, agents, employees, Nancy Criswell, Bill Criswell, and any and all security personnel, other businesses associated with the above, harmless of and from any and all liability including, but not limited to, theft, adverse weather conditions, closure due to public safety, and further fully indemnify and hold harmless the aforementioned from any and all damages arising from my/your participation and/or conduct in this Art Attack event.
